## Important Information:

#### **Carry-Forward Marks:**

You may carry forward marks from November 2024 or June 2025 under two scenarios:

- To complete a Cambridge International A Level (using marks from a previous full AS Level)
- 2. To improve a previous grade (non-exam assessments like coursework/speaking tests)
- 3. Please note:
- Marks must be from within the past 13 months
- IGCSE/O Level marks can only be carried forward once
- AS Level marks can be carried forward twice
- Candidates must be entered for the relevant 'Mark Carried Forward' component

## **Retake Entries:**

A retake is valid when:

- The same syllabus (regardless of option code) was taken in June 2025
- You select the retake option at the time of entry (cannot be added later)
- Applies only to the November exam series

## **Speaking Exams:**

- If registering for subjects with speaking components, please ensure they align with the testing window.
- If you have not received your speaking exam schedule by 24 October 2025, please follow up.

## **Exam Fees and Payment:**

- View exam fees within the registration portal.
- Your registration will only be processed once full payment is received.
